#### 6. Division of Law Enforcement Services (DLES) Update

- a. Bureau of Justice Information and Analysis (BJIA) Derek Veitenheimer
  - i. Wisconsin Statutes Chapter 51.15 Emergency Detention
    - Concerns have been raised by the Wisconsin State Legislature and law enforcement on the status of the emergency detention transports for individuals who may cause physical harm to themselves or others due to mental disability or substance abuse.
    - BJIA is working with the Wisconsin Chiefs of Police Association (WCPA) to put together a survey
      to identify concerns and agency practices regarding the transports. Eventually, the information
      will be shared with the legislature to improve conditions and practices under Chapter 51.15. The
      survey will be sent out in the next couple of weeks and will remain open for about a month.
  - ii. Use of Force Data Collection
    - The FBI has launched a national Use of Force data collection program that is collecting data on incidents involving serious injury, death, and a firearm discharged at or in the direction of a person.
    - BJIA has partnered with the Wisconsin State Patrol to develop a Use of Force reporting form through the Traffic and Criminal Software (TraCS). The program will officially be launched in November or December 2019 with the expectation that all Wisconsin agencies will begin participating in 2020.
    - The Bureau of Justice Assistance will also start collecting information on arrest related deaths through the Deaths and Custody Reporting Act.
    - To satisfy the requirements for the FBI and Bureau of Justice Assistance, BJIA has decided to create one data collection mechanism through TraCS and distribute information to the necessary bureaus. BJIA is developing an online submission for agencies who do not use TraCS as well as allowing bulk submissions for larger agencies.
    - BJIA will only be collecting the required data for the FBI and Bureau of Justice Assistance but may expand the scope later on.
  - iii. National Incident-Based Reporting System (NIBRS)
    - The FBI has an initiative to transition the country from summary-based uniform crime reporting to incident-based uniform crime reporting. An incident-based reporting system will gather more information and provide a better understanding of the crimes committed in different areas.
    - In Wisconsin, there are about 163 certified agencies with an additional 38 in testing, making about 68% of the population covered by incident-based reporting. There is grant funding available to help agencies with the transition by the deadline of January 2021.

 BJIA is collaborating with the Wisconsin State Patrol on the possibility of creating an Incident-Based Reporting form within TraCS. This would help smaller agencies who cannot afford a new records management system.

#### b. Crime Information Bureau (CIB) - Walt Neverman

- i. The TIME system had over 168,000 transactions per day in 2018. The application has been experiencing a lot of outages and the objective is to move the system into two redundant data centers, which will provide a more stable service.
- ii. National Crime Information Center (NCIC) has new mandates for access to other states' crime information that will be required by next year.
- iii. CIB is looking to upgrade Portal 100 to Portal XL. This system will also be moving to two different data centers to create redundancy if one center should be down. There will be some testing and outages with the transition.
- iv. The Automated Fingerprint Identification System (AFIS) is upgrading and also moving to two data centers for more stability. Agencies will be contacted regarding a LiveScan configuration change with the AFIS update. LiveScans will need to switch from an IP address to a DNS name endpoint making it easier to transfer from one data center to the other as needed.
- v. CIB has conducted about 55,000 background checks through the Handgun Hotline so far this year. In addition, there are nearly 24,000 new and renewed CCW licenses as of May 12, 2019. In total, there are over 362,000 active, valid CCW licenses in the state.
- vi. National Instant Criminal background Checks System
  - The Fix NICS Act is an initiative to increase the number of warrants that are given to the National Crime Information Center (NCIC).
  - For all warrants entered into the TIME system prior to July 2018, the user had a choice to send
    warrants to the NCIC in addition to the Wisconsin "hot files." If the user did not choose to
    submit to the NCIC, there could be a felony warrant in the TIME system that is not visible to
    officers outside the state.
  - Since July 2018, CIB has changed the warrant entry process so that all misdemeanor and felony
    warrants are entered into NCIC to comply with the Fix NICS Act. Nearly 90% of the felony
    warrants are in NCIC, and CIB projects that all felony and misdemeanor warrants will be in the
    system within four years.

## 7. Training & Standards Bureau Update (T&S)

- Assistant Attorney General Frank Sullivan has been hired to the Training and Standards Bureau to replace
  David Perlman. A proposal is in place to divide T&S into two different bureaus under their own directors;
  one will be Training and Standards and the other will be Justice Programs. Until this transition is final and a
  new director is hired, Frank Sullivan is serving as Acting Director of the Training and Standards Bureau.
- The Tactical Education Consultant position has been filled by Ron Betley from Rock County Sheriff's Office and Blackhawk Technical College. He will start at the end of June.
- John Morrissey continues to work on officer wellness and suicide prevention trainings. The first Peer Support training will be in La Crosse on June 10 – June 13, 2019. The objective is to create local peer support teams around the state that are divided similarly to the five T&S Field Representative regions.
- Critical Incident Training (CIT) grants close on May 20, 2019.
- Technical assistance grant applications are still accepted for specialized training on dealing with youth in departments as well as fair and impartial policing. This will help the agencies remain in compliance with Juvenile Justice Grants.
- Danielle Long helped coordinate the Drug Take Back event at the end of April, where 284 agencies
  participated in collecting 58,408 pounds of prescription and over the counter drugs. There are currently
  475 permanent drug drop boxes around the state.
- The Heroin and Opioid Summit will tentatively be held at the Grand Geneva Resort in Lake Geneva, October 15-16, 2019.

• Marathon County Sheriff's Office and Medical Examiner's Offices are piloting the practice of accepting pharmaceuticals at death scenes.
