### **Preparatory Training Waiver Requests**

#### **Instructor Waiver Requests**

a. Swartz, Michael – Blackhawk Technical College Staff recommends against a waiver.

#### Discussion:

Chief Ruzinski asks staff if Mr. Swartz is teaching at Blackhawk Technical College and if the college has encouraged him to request a waiver? Thessa Phillips states that Mr. Swartz is currently employed by Blackhawk Technical College as a security officer. He had heard about the LESB instruction and wanted to teach general jail topics and handgun in the academy.

**Motion** to accept staff recommendations for instructor waiver requests. Move by Anna Ruzinski, second by Michelle Viste. Motion carried unanimously.

- 5. Requests for Extension of the Time Limits to Gain Employment and Requests for Extension of the Time Limits to Complete Preparatory Training for Officers & Civilians.
  - a. Kaufmann, Savannah Fond du Lac County Sheriff's Office Staff recommends Savannah Kaufmann receive an extension until December 31, 2020 to allow her to complete preparatory training.

- Gottschalk, Michael Langland County Sheriff's Office
   Staff recommends Michael Gottschalk receive an extension until December 31, 2020 to allow him to complete preparatory training.
- Vollmar, Logan Langlade County Sheriff's Office
   Staff recommends Logan Vollmar receive an extension until June 1, 2021 to allow him to complete preparatory training.
- d. Franklin, Melissa UW Madison Police Department
   Staff recommends Melissa Franklin receive an extension until June 1, 2020 to allow her to complete preparatory training.

Staff amends the recommendation for Melissa Franklin to receive an extension until June 30, 2020. Jerry Mullen has been informed by the Madison College academy director that they will not be conducting final scenarios and the exit PRT until June.

#### Discussion:

Chief Ruzinski asks if the Melissa Franklin has requested an extension before this meeting? Jerry Mullen states that this is Ms. Franklin's extension request.

**Motion** to accept staff recommendations for extension requests of time to complete basic training requirements with the amendment to allow Melissa Franklin until June 30, 2020 to complete basic training. Move by Anna Ruzinski, second by Michelle Viste. Motion carried unanimously.

### 6. Training & Standards Bureau Update (T&S)

- Steve Wagner has been hired as the new Director of the Training and Standards
  Bureau. Mr. Wagner started working in Training and Standards on April 13, 2020 after
  working as a Law Enforcement Officer at Racine Police Department for 29 years.
- Training and Standards is looking at possibly providing an online option to complete
  the Instructor Updates for fall 2020 and spring 2021 due to COVID-19 and budget
  restrictions. Staff is working on how to make the different breakout sessions and the
  legal update work with an online platform.
- The academies continue working with Training and Standards to make sure the Wilenet information shows how they are currently holding their basic training courses. T&S is planning to have a meeting with the academy directors on June 22, 2020.
- Laurie Valley has recorded two podcasts for the Sexual Assault Kit Initiative (SAKI). In
  each podcast Laurie interviews a subject matter expert on a topic to do with sexual
  assault training. Attorney General Josh Kaul was the subject matter expert on her first
  podcast and the Crime Lab's Administrator and Deputy Administrator, Nikki Roehm
  and Jen Naugle, were interviewed on her second podcast. Once the podcasts are
  approved, they will be posted on Wilenet.
- The Curriculum Advisory Committee (CAC) will meet on May 21, 2020. Training and Standards will present the CAC with updates to the Handgun Qualification curriculum as well as other curriculum updates.
- Chief Ruzinski asks Training and Standards if the academy directors think their online instruction is adequate? T&S cannot say for sure what the academy directors are thinking about online training, but there are some concerns about bringing recruits back into the classroom.

- Some academies have tried to do in-person instruction with smaller groups, but technical colleges are able to put in their own restrictions on the manner of instruction during the pandemic.
- All Training and Standards can do is to provide guidance with how to conduct online training or how to conduct in-person training safely. Online instruction at some academies may have to continue for a while longer.
- Chief Ruzinski is concerned that the academies may want to continue using online instruction following the pandemic.
- Jerry Mullen states that the academy status chart has been updated in Wilenet for all academies except for Chippewa Valley Technical College. Some academies are holding in-person classes with small groups.
- Chief Domagalski asks if online instructor updates will allow for more people to
  complete the update requirement? Dana Vike states that attendees usually prefer inperson instruction especially for the hand-on topics like handgun or vehicle pursuit.
  Hopefully, instructors will see the online training as an opportunity to complete the
  requirement early and not wait to complete it in person.
