Preparatory Training Waiver Requests

- 5. Requests for Extensions of the Time Limits to Gain Employment and Requests for Extensions of the Time Limits to Complete Preparatory Training for Officers and Civilians.
 - a. Crowe, Eliza Bayfield County Sheriff's Office
 Staff recommends the applicant receive an extension until 12/1/2022 to allow them to complete preparatory jail officer training.
 - Auseth, Taylor Buffalo County Sheriff's Office
 Staff recommends the applicant receive an extension until 12/1/2022 to allow them to complete preparatory jail officer training.
 - c. Weiss, Christopher Buffalo County Sheriff's Office Staff recommends the applicant receive an extension until 12/1/2022 to allow them to complete preparatory jail officer training.
 - d. Moczynski, Jason Fall River Police Department Staff recommends the applicant receive an extension until 12/1/2021 to re-complete the exit PRT. The technique used by Gateway Technical College for the sit-ups is acceptable, however approval to use a different technique was not requested by the college in advance.
 - e. Proudfoot, Bailey La Crosse Co Juvenile Detention Center Staff recommends that the applicant receive an extension until 9/1/2022 to complete preparatory SJD training.
 - f. Donovan, Ashley Langlade County Sheriff's Office

 - Applicant passes the Jail Reciprocity examination.
 - Applicant completes a minimum of 200 hours of jail field training (to be documented on the Jail Reciprocity application).
 - g. Bukovsky, Brandon Milwaukee County House of Correction Staff recommends the applicant receive an extension until 4/1/2022 to allow them to complete preparatory jail officer training.
 - h. Martin, Austin Northwest Regional Juvenile Detention Center Staff recommends the applicant receive an extension until 6/1/2022 to allow them to complete preparatory SJD officer training.
 - Morris, Dustin Northwest Regional Juvenile Detention Center Staff recommends the applicant receive an extension until 6/1/2022 to allow them to complete preparatory SJD officer training.
 - j. Brathol, Kali Pierce County Sheriff's Office Staff recommends the applicant receive an extension until 6/1/2022 to allow them to complete preparatory jail officer training.

- Marshall, Adam Sawyer County Sheriff's Office
 Staff recommends the applicant receive an extension until 6/1/2022 to allow them to complete preparatory jail officer training.
- m. Van de Pas, Marike Sheboygan County Sheriff's Office Staff recommends the applicant receive an extension until 6/1/2022 to allow them to complete preparatory jail and SJD officer training.
- n. Bailey, Andrew Waupaca County Sheriff's Office Staff recommends the applicant receive an extension until 9/1/2022 to allow them to complete preparatory law enforcement officer training.

Discussion:

- Sheriff Delain expresses concern about the amount of jail academy extension requests. He understands the reason for the requests and expects the LESB to receive more. Sheriff Delain states that while he knows it is difficult to get officers into the training due to staffing shortages, sheriffs' offices should be trying to get their officers enrolled in training as early as possible.
- Chief Bliven suggests there may be value to increasing the time to complete the jail academy from 12 months to 15 or 18 months. Sheriff Delain will discuss this possibility with other sheriffs at their conference in December.
- Sheriff Parks agrees with the other committee members. He adds that the facilities have more liability factors as officers continue to work without academy training. At the same time, it is sometimes impossible to send officers to training as there are mandatory staffing levels to run the facility.
- TSB Director Steve Wagner notes that the staffing shortages in sheriffs' offices can cause academies to face issues getting enough jail instructors to teach in the academy.
- Sheriff Delain states that the LESB will continue to monitor and assist where it can.

Motion to approve staff recommendations for extension requests of time to re-gain employment and time to complete basic training requirements. Move by Michelle Viste, second by Benjamin Bliven. Motion carried unanimously.

6. Administrative Code Chapters LES 1 - 9 Update

Training and Standards proposes updating the administrative rules of the LESB. A draft of the Scope Statement for the proposed changes is presented to the Executive Committee. If signed by the LESB Chairperson today, the Scope Statement will be submitted to the Governor's Office. If approved, the Scope Statement will be published in the Administrative Register, and then the DOJ is allowed to begin drafting the revised administrative rules.

The LESB could possibly create a subcommittee of members to review the current administrative rules and identify changes to be made.

Sheriff Delain states that he will not sign the statement without approval from the Executive Committee. He is seeking a motion from the committee to support him signing the statement.

Motion to support LESB Chairman Todd Delain in signing the Statement of Scope of Proposed Rules as presented by staff. Move by Anthony Burrell, second by Michelle Viste. Motion carries unanimously.

7. Training and Standards Bureau (TSB) Update

- Region 2 and Region 5 Field Representative positions are currently posted for applicants to apply.
- TSB sent out guidance on Act 75 to law enforcement agencies. If there are any questions, agencies are encouraged to contact Steve Wagner.
- Act 82 was passed on November 5, 2021 and requires law enforcement to provide
 personnel records to other law enforcement agencies upon request. Training and
 Standards is concerned about Section 9 of Act 82 as it references the LESB decertifying
 officers if they resign in lieu of termination or are terminated for just cause from an
 agency. TSB is currently navigating through Section 9 and what the process will be.
 - The Executive Committee expresses concern over Section 9 and expects there will be more appeal hearings for decertified officers.
 - Sheriff Delain asks staff to review the current options in Acadis for removing an officer and provide possible additions. Mr. Wagner agrees that there should be additional separation options for removing an officer.
 - Assistant Attorney General Frank Sullivan agrees that additional research and discussions will need to be done.
