4. Requests for Waivers of Training & Education Requirements for Officers, Civilians, and Instructors.

### **Preparatory Training Waiver Requests**

Successful completion will result in certifiability as a law enforcement officer in Wisconsin for one year from the date of the exam. The applicant shall complete the law enforcement reciprocity examination by November 8, 2023.

(Kline previously applied for reciprocity and was declined due to a disqualifying conviction in Minnesota. Kline has since received a pardon from the Governor's Office in Minnesota and has been determined to have no disqualifiers pursuant to the pardon which nullifies the conviction)

Staff recommends successful completion of the reciprocity examination. Successful completion will result in certifiability as a law enforcement officer in Wisconsin for one year from the date of the exam. The applicant shall successfully complete the law enforcement reciprocity examination by November 8, 2023.

## k. Martinez, Armando – Pre-Employed

Staff recommends successful completion of the reciprocity examination with the following conditions: Applicant shall maintain full time employment with his current agency until 12/16/2022, and the applicant shall not be officially approved until 12/17/2022 (one year of post academy full time law enforcement employment)

Pursuant to the above conditions, the applicant shall complete the law enforcement reciprocity examination by December 17, 2023.

## I. Mayhew, Joseph – Pre-Employed

Staff recommends **against** completion of the law enforcement reciprocity examination. The applicant may submit an application for the law enforcement reciprocity examination any time after 3/14/2023, provided that the applicant maintains full time employment with his current employer.

#### m. McCombs, Andrew – Pre-Employed

Staff recommends successful completion of the law enforcement reciprocity examination. Successful completion will result in certifiability as a law enforcement officer in Wisconsin for one year from the date of the exam. The applicant shall successfully complete the law enforcement reciprocity examination by November 8, 2023.

## n. Rubo, Gregory – Pre-Employed

Staff recommends successful completion of the law enforcement reciprocity examination. Successful completion will result in certifiability as a law enforcement officer in Wisconsin for one year from the date of the exam. The applicant shall successfully complete the law enforcement reciprocity examination by November 8, 2023.

#### o. Rykal, Jonathan – Pre-Employed

Staff recommends successful completion of the law enforcement reciprocity examination. Successful completion will result in certifiability as a law enforcement officer in Wisconsin for one year from the date of the exam.   Staff recommends successful completion of the reciprocity examination. The applicant shall complete the law enforcement reciprocity examination within their probationary period and no later than 8/25/2023.

dd. Streif, Naomi - Sauk County Sheriff's Office

Staff recommends successful completion of the reciprocity examination. Although the applicant does not meet the requirements for reciprocity testing, specifically the requirement to hold a minimum of one year of full-time law enforcement employment, the recommendation to approve the waiver is based on the following mitigating circumstances: The applicant held employment as a certified full-time law enforcement officer in lowa for close to 11 months, the applicant has earned a bachelor's degree and master's degree in Criminal Justice, the applicant has relevant work experience in other aspects of the criminal justice system including Probation and Parole, mental health and youth counselling, the applicant will receive 13 weeks of field training, and the applicant is currently working as a jail officer in Sauk County.

Subject to the approval of the LESB, the applicant shall complete the law enforcement reciprocity examination within their probationary period and no later than 9/14/2023. The Sauk County chief deputy has submitted a letter of recommendation on behalf of Streif. The letter is included in the packet.

ee. Turner, Michael – Appleton Police Department
Staff recommends successful completion of the reciprocity examination. The applicant shall complete the law enforcement reciprocity examination within their probationary period and no later than 3/14/2023.

**Motion** to accept staff recommendations as presented for preparatory training waiver requests. Move by Benjamin Bliven, second by Michelle Viste. Motion carried unanimously.

**Discussion:** Chief Bliven asks if certification standards from other states are taken into consideration for reciprocity applicants? For instance, Joseph Mayhew had a five-year gap in service while working in Kansas. What are their certification standards that allowed him to work after five years? Jerry Mullen states he did not evaluate Mr. Mayhew's employment history too closely because he was not eligible for reciprocity based on his current employment. If he reapplies for reciprocity, Mr. Mullen will inquire about the five-year gap in service.
