- 1. Call the Meeting to Order Todd Delain called the meeting to order at 10:01 am.

4. Requests for Waivers of Training & Education Requirements for Officers, Civilians, and Instructors.

Instructor Waiver Requests

a. Gerisch, Falynne – Fox Valley Technical College

Starting in 2024, the Wisconsin State Patrol will reinstate the 60-college credit requirement.

Todd Delain remarked that this is important information, and it will be discussed with the Wisconsin Chiefs and Sheriff's associations.
