4. Requests for Waivers of Training and Education Requirements for Officers, Civilians, and Instructors.

Preparatory Training Waiver Requests

- a. Arnold, Kenneth Pre-Employed Staff recommends successful completion of the reciprocity examination. Successful completion will result in certifiability as a law enforcement officer in Wisconsin for one year from the date of the exam. The applicant shall complete the law enforcement reciprocity examination by August 13, 2025.
- b. Biadasz, Larsen Pre-Employed Staff recommends successful completion of the reciprocity examination. Successful completion will result in certifiability as a law enforcement officer in Wisconsin for one year from the date of the exam. The applicant shall complete the law enforcement reciprocity examination by August 13, 2025.
- c. Erickson, Tyler Pre-Employed Staff recommends successful completion of the reciprocity examination. Successful completion will result in certifiability as a law enforcement officer in Wisconsin for one year from the date of the exam. The applicant shall complete the law enforcement reciprocity examination by August 13, 2025.
- d. Geneman, Austin Pre-Employed
 Staff recommends successful completion of the reciprocity examination. Successful
 completion will result in certifiability as a law enforcement officer in Wisconsin for one

f. Krahn, Adam – Pre-Employed

Staff recommends successful completion of the reciprocity examination. Successful completion will result in certifiability as a law enforcement officer in Wisconsin for one year from the date of the exam. The applicant shall complete the law enforcement reciprocity examination by August 13, 2025.

g. Lynn, Selwyn – Pre-Employed

Staff recommends successful completion of the reciprocity examination. Successful completion will result in certifiability as a law enforcement officer in Wisconsin for one year from the date of the exam. The applicant shall complete the law enforcement reciprocity examination by August 13, 2025.

h. Neumann, Trae - Pre-Employed

This waiver was tabled at the 6/4/2024 LESB meeting pending additional information. Staff recommends approval of the waiver of the one-year requirement to hold full time employment based on the following mitigating circumstances:

- Applicant provided payroll records that reflected a total of 1,586 hours in the nine-month period of employment. This averages to 44 hours per week.
- Applicant has gained significant experience (responded to over 600 calls for service) due to manpower shortages.
- Applicant has 8 years military experience in corrections.

Discussion:

This request was tabled at the last meeting pending requested information. The requested payroll records were received. As a result, Jerry Mullen recommends approval of the waiver of the one-year requirement to hold full time employment. The time at the Academy while employed by the Winston-Salem Police Department does not count toward eligibility for reciprocity, which is why he is short of the one-year requirement. This is his second waiver; the first was for reciprocity to go through the academy and now he is requesting a waiver for one-year full-time law enforcement employment.

i. Peterkin, Travis - Pre-Employed

Staff recommends successful completion of the reciprocity examination. Successful completion will result in certifiability as a law enforcement officer in Wisconsin for one year from the date of the exam. The applicant shall complete the law enforcement reciprocity examination by August 13, 2025.

j. Salazar, Robert – Pre-Employed

Staff recommends successful completion of the reciprocity examination. Successful completion will result in certifiability as a law enforcement officer in Wisconsin for one year from the date of the exam. The applicant shall complete the law enforcement reciprocity examination by August 13, 2025.

k. Shipanik, Daniel - Pre-Employed

Staff recommends successful completion of the reciprocity examination. Successful completion will result in certifiability as a law enforcement officer in Wisconsin. The applicant shall complete the law enforcement reciprocity examination by August 13, 2025.

I. Sosa, Sifedo – Pre-Employed

Staff recommends successful completion of the reciprocity examination. Successful completion will result in certifiability as a law enforcement officer in Wisconsin for one year from the date of the exam. The applicant shall complete the law enforcement reciprocity examination by August 13, 2025.

m. Sullivan, Jeremy - Pre-Employed

Staff recommends successful completion of the reciprocity examination. Successful completion will result in certifiability as a law enforcement officer in Wisconsin for one year from the date of the exam. The applicant shall complete the law enforcement reciprocity examination and gain employment by 1/18/2025.

Discussion:

Jerry Mullen had recommended approval of the reciprocity examination. He would like to amend his recommendation from approval to tabling this request until the full board meeting in September as verification has not been received from the Vermont POST. Correction to the notes: last date of employment with the Vermont State Police was January 2022, which is still within the three-year window.

n. Timmers, Teagan - Pre-Employed

Staff recommends successful completion of the reciprocity examination. Successful completion will result in certifiability as a law enforcement officer in Wisconsin for one year from the date of the exam. The applicant shall complete the law enforcement reciprocity examination by August 13, 2025.

o. Vasseur, Andrew – Pre-Employed

Staff recommends successful completion of the reciprocity examination. Successful completion will result in certifiability as a law enforcement officer in Wisconsin for one year from the date of the exam. The applicant shall complete the law enforcement reciprocity examination by August 13, 2025.

McClain Jr, Ralph – Milwaukee Police Department Staff recommends in favor of a waiver for Officer McClain. He will be recertified effective September 1, 2024, with a certification expiration date of September 1, 2027.

- 5. Requests for Extensions of the Time Limits to Gain Employment and Requests for Extensions of the Time Limits to Complete Preparatory Training for Officers and Civilians
 - a. Fisher, Sarai Barron County Sheriff's Office Staff recommends conditional approval of the waiver request (pending the receipt of documentation of the number of hours the applicant worked at Barron PD). The recommendation for approval is based on the following mitigating circumstances/conditions:
 - The applicant shall be required to pass the Wisconsin Law Enforcement Reciprocity exam by 2/1/2025.
 - The applicant has been employed as a dispatcher since February of 2020.

Discussion: Sheriff Delain suggested that when speaking to Ms. Fisher, find out if there is anything from the sheriff's department that could be added to the files.

- d. LeNoble, Alex Forest County Sheriff's Office
 Staff recommends the applicant receive an extension until 6/10/2025 to allow him to complete preparatory jail officer training.
- e. McAlister, Zachary Iowa County Sheriff's Office
 Staff recommends the applicant receive an extension until 9/1/2025 to allow him to complete preparatory jail officer training.
- f. Reif, Nicholas Kewaunee County Sheriff's Office

Staff recommends the applicant receive an extension until 7/31/2025 to complete preparatory jail officer training.

- m. Berken, Aaron Pre-employed
 Staff recommends approval of the waiver request. The recommendation for approval is based on the following mitigating circumstances/conditions:
 - The applicant has extensive law enforcement experience (25 years).
 - The extension request is de minimus (less than 90 days)
 - The applicant shall gain law enforcement employment by 10/31/2024.
 - The applicant shall be required to pass the Wisconsin Law Enforcement Reciprocity exam by 12/1/2024.
- n. Bloss, Keith Pre-employed

Staff recommends approval of the waiver request. The recommendation for approval is based on the following mitigating circumstances/conditions:

- The applicant meets the requirements for the Reciprocity exam.
- The applicant has a minimal break in employment.

The applicant shall not be required to complete the Wisconsin Law Enforcement Reciprocity exam based on his previous successful completion of the exam.

Discussion: Mr. Bloss passed the Reciprocity exam on August 25, 2020, which is almost 4 years ago. Jerry Mullen would like to amend his recommendation to add the condition

that he be required to pass the Wisconsin Law Enforcement Reciprocity exam by December 31, 2024.

Motion to approve staff recommendations, which include to table Sarai Fisher's request until the September full LESB Meeting, as well as to amend the recommendation for Keith Bloss to pass the Wisconsin Law Enforcement Reciprocity exam by December 31, 2024. 6. Training and Standards Bureau Update

Training and Standards has filled the Region 4 vacancy. Melissa Elliott came from Western Technical College as the academy director. All positions in Training and Standards are full.

7. Roundtable
