6. Discussion of End of Employment Status for Vasken Harioan

Vasken Haroian was hired as a police officer for the City of Racine Police Department on December 19, 2022, and he attended the 720-hour law enforcement academy at Gateway Technical College. While attending the academy, his employment was "Terminated for Cause" on May 2, 2023. Mr. Haroian contacted the Training and Standards Bureau to appeal his end of employment status entered into ACADIS. Director Betley contacted the Police Department to determine if the end of employment status is correct. The agency administration confirmed Mr. Haroian's end of employment status is accurate. The appeal request was denied by Director Betley. Mr. Haroian is now asking the LESB Executive committee to review the matter.

Mr. Haroian addressed the board giving specifics of his employment status.

Once Mr. Haroian had fully explained the issue, it was explained that the LESB does not investigate grievances, they simply ensure there was no mistake when the status was entered. Mr. Haroian was advised that he should address the issues with the Racine Police Department.

Motion that the Executive Board of the LESB take no action on the subject's request to the LESB to change his end of employment status in ACADIS. Move by Timothy Carnahan, second by Kalvin Barrett. Jessie Metoyer will abstain from voting. Motion carried unanimously.

7. Training and Standards Bureau Update

The Training and Standards Bureau is actively reviewing the directives established by the two motions that were passed by the full board at the December 3, 2024, LESB quarterly meeting

regarding the PRT. The matter will be put back on the agenda for the March 4, 2025, LESB quarterly meeting. The Training and Standards Bureau is seeking further clarification and assistance from the PRT subcommittee to comply with the directives.

8. Roundtable

Steven Wagner spoke with the newest member of the LESB, City of St. Francis Mayor Ken Tutaj, who is very excited to join the group. He won't be on the Executive Committee.
