#### c. Instructor Waiver Requests

- Holmstrom, Joseph Douglas County Sheriff's Office
   Staff recommends in favor of a waiver for Joseph Holmstrom. He will be recertified effective September 1, 2025, with a new certification expiration date of September 1, 2028.
- Rosenblum, Aaron Eau Claire County Sheriff's Office
   Staff recommends against waiving the certified occupational experience requirements
   for instructor certification. The individual will qualify for certification upon acquiring
   three years of full-time experience or a total of 6,000 hours of certified occupational
   experience.

3. Smallwood, Mark – Portage County Sheriff's Office Staff recommends in favor of the waiver, allowing Mark Smallwood to request instructor certification in SFST more than two years from course completion once a signed application has been submitted to the Training and Standards Bureau.

Discussion: Aaron Rosenblum was employed at Northwest Juvenile Detention Center from 2018 to 2021, but never went through the academy. He then moved on to the Eau Claire County Sheriff's Office as a jail officer from 2021 to present. He completed the academy in February 2025 and was certified June 3, 2025. During that timeframe he became a dual certified law enforcement officer, attending the law enforcement academy and became certified in December 2024. He is requesting to waive the three years of occupational experience to become a general jail instructor at the academy he completed in February. Timothy Carnahan noted that although he was not certified during most of his occupational experience, he has a lot of occupational experience time. Thessa acknowledged this but added that his occupational experience is in secure juvenile detention. He can currently instruct any other topic without a waiver. Todd Delain sends his staff to the jail academy and the juvenile detention academy; it is similar. Aaron's letter noted that not attending the academy was due to staffing issues. He is requesting to instruct in the jail academy and a technical college would like to have him as there is a shortage of instructors. Experience is the obstacle in this unique case. Ron Betley added that this is precedence setting, and he backs staff recommendations. Steve Wagner also said that staff recommendations follow policy, however, this could reach to the level of a waiver due to the circumstances. Thessa offered a suggestion that the applicant reapply in one year as the board has waived a request with one year of experience for DOC. She also stated that there is another waiver coming with similar circumstances. He wants to instruct in the general jail topics (taught only in the jail academy) and eventually defensive tactics and scenarios (taught in any academy).

**Motion** to amend the recommendation for Aaron Rosenblum that his occupational experience request be waived after June 1, 2026, and to approve instructor waiver request recommendations as presented by staff for Joseph Holmstrom and Mark Smallwood. Move by Todd Delain, second by Jean Galasinski. Motion carried unanimously.

# bb. Felician, Paul – Pre-employed

• The applicant has over 29 years of law enforcement experience.

- The applicant has been working in a law enforcement role (although non-sworn) as the director of the Wisconsin Counterdrug program
- The applicant shall gain employment by 12/1/2025
- The applicant shall be required to pass the Wisconsin Law Enforcement Reciprocity exam by 2/1/2026.

# cc. Gray, William - Pre-employed

Staff recommends **denial** of the waiver request. The recommendation for denial is based on the following:

- The applicant's deadline to regain employment was 2/18/2025.
- The applicant's most recent employment with the Department of Revenue was primarily a regulatory role, not an enforcement role.

# dd. Megna, Anthony - Pre-employed

Staff recommends approval of the waiver request. The recommendation for approval is based on the following mitigating circumstances/conditions:

- The applicant has over 40 years of law enforcement experience.
- The applicant worked over 1200 hours in the preceding twelve months prior to his retirement from Outagamie County SO.
- The applicant shall not be required to pass the Wisconsin Law Enforcement Reciprocity exam.

#### ee. Welhouse, Estelle – Pre-employed

Staff recommends approval of the waiver request for an extension of sixty days. The deadline to gain employment shall be 12/15/2025. A letter from Wauwatosa PD is included in the packet.

#### 6. Training and Standards Bureau Update

Dana Vike and Ron Betley are working with the Division of Legal Services to review administrative codes LES 1-9. Attorneys have drafted a scope statement that will be brought to the LESB Quarterly Meeting for review and approval to go forward with the rulemaking process to bring the administrative codes in line with the current LESB Policy and Procedure Manual.

PRT Update-The state budget passed, now Ron Betley will be working with the Budget and Finance and Procurement offices to complete a Request for Information. This process will produce a better understanding of what the actual cost of conducting a job task analysis and developing a new PRT will be. That information will be presented to the administration of the Department of Justice for guidance.

Education Consultant Lauren Racey's project position was cut from the state budget and her position will expire at the end of September. Lauren was hired as a project employee to develop virtual curriculum and transfer current curriculum to a virtual format.

#### 7. Roundtable

Technical College System Administrative Code 10 Update-Todd Delain was contacted by the AG's office and was advised that the Technical College System has requested outside representation to represent their interest and felt that the AG's Office might have a conflict of interest representing both the LESB and the Wisconsin Technical College System. The Technical College System has requested the Governor's Office to provide outside representation, which was granted. Todd Delain had sent a letter to the Governor's Office requesting outside representation if the AG's Office could not represent the LESB. Todd was contacted on August 14 and was notified that the Governor's Office has retained Attorney Emery Harlan from the MWH Law Group to represent the LESB on this issue. Todd Delain spoke to Attorney Harlan and gave him a general overview of the issues. Todd Delain will provide Attorney Harlan with all applicable documents and information.

Todd Delain thanked Administrator Wagner for his exemplary service to the State of Wisconsin and law enforcement. Steve has been an outstanding DLES leader and will be missed! Mark Rather has some big shoes to fill.

Jessie Metoyer thanked Steve for his assistance throughout the years and is grateful for his guidance.
