

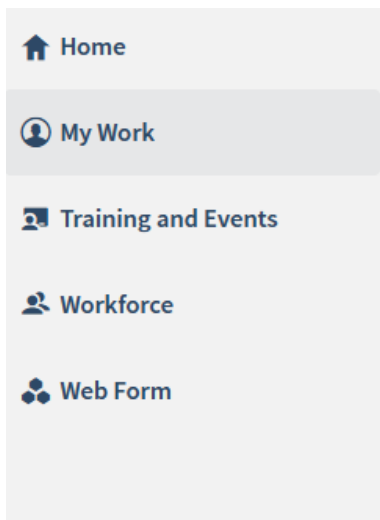
Acadis Portal Training for TACs

As a TAC, you will have access to more in the Acadis Portal than typical end users. You will be able to register others for classes and view a list of your personnel (Workforce) and their certifications.

When you log in, you will still see your profile with any in-progress training, a list of your certifications, and upcoming training.

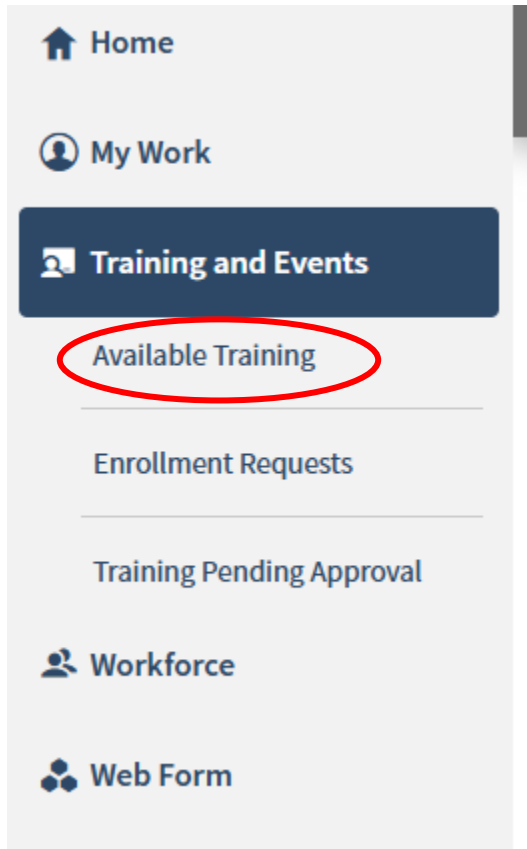


