Dana:

I have been corresponding for some time with Attorney Rob Orcutt who represents the Stockbridge-Munsee Tribe regarding the tribes efforts to satisfy the statutory requirements for recognition of their tribal police department under Wis. Stat. § 165.92 and § 66.0313. AAG Tom Creeron also worked with Mr. Orcutt on this issue for some time prior to Creeron's retirement.

I have reviewed the insurance documents and other documents that Mr. Orcutt has supplied and I have concluded that they meet the applicable statutory requirements and that the Bureau should be able to proceed with recognition of the Stockbridge-Munsee tribal PD. Pertinent emails and supporting documents are attached to this email.
